## **Creating High Performing Boards**

An independent board review plays a vital role in promoting good governance, enhancing decision-making processes, building stakeholder trust, managing risks, and improving organisational performance and sustainability. Assessing the board's effectiveness enables to capitalise on its strengths and address any shortcomings that may hinder its ability to fulfil its responsibilities.

This process, when conducted effectively, leads to a more cohesive, aligned, and high-performing board, driving overall organisational performance. Our approach ensures that feedback is not influenced by internal biases or conflicts of interest, leading to more accurate insights into the board's strengths and weaknesses.

#### Tailored Approach for Sport and Recreation Boards

A Code for Sports Governance, requires funded sports organisations to 'undertake an external evaluation of the Board facilitated at least every four years to seek independent perspective on the performance, effectiveness, culture and function of the Board.'

Our board review provides an assessment of a board's effectiveness and offers assurance to its stakeholders. This process allows boards to demonstrate their accountability to improve performance and adherence to best practices.

Our review focuses on the board's strategic direction, director conduct and contribution, board's operation as an entity, future focus and committee effectiveness.

## WHAT WE OFFER

- Our process follows sector best practices, A Code for Sports Governance, and industry expertise. Board evaluation is a key governance tool, helping boards and trustees identify areas for improvement and reflect on board dynamics.
- Our structured seven-step board review process assesses performance against governance standards. It evaluates strategic alignment, governance practices, board dynamics, and individual contributions to ensure effective leadership.
- We use a mix of quantitative and qualitative methods, including board surveys and individual director interviews. This comprehensive approach provides valuable insights into board performance and effectiveness.
- By combining feedback with board observations, we identify key themes, trends, strengths, and areas for improvement, supporting continuous governance development.

#### Key steps of the evaluation process:

**Initial Consultation** – We'll consult with the Chair, CEO, and governance lead to review current processes, define key focus areas, and finalise the evaluation timeline.

**Board Survey –** We'll create a tailored survey for directors, building on the internal evaluation, to assess areas like strategy, composition, and individual performance.

**Board Observation –** We'll observe a board meeting to understand dynamics, interactions, and the meeting process.

**Director Interviews –** We'll conduct one-on-one interviews with directors to explore key issues in-depth.

Analysis of Responses – We'll analyse survey and interview responses to identify strengths, gaps, and actionable improvements.

**Board Evaluation Report –** We'll produce a report summarizing findings, identifying strengths and weaknesses, and recommending improvements to foster high performance.

**Presentation** – We'll present the final evaluation results, actions, and next steps for the board.
